Topic: European Union sanctions in the context of the aggression of the Russian Federation

against Ukraine

As a part of "Research visits of the AMU EU EX/ACT team in foreign academic centers" dr. Joanna Skrzypczyńska visited the European Union Center at the University of Miami, Florida, USA. During her stay at the Center, Dr. Skrzypczyńska met with the director of the Center, prof. Joaquín Roy (Jean Monnet Chair Director, European Union Center). She also participated in a lecture on Russian foreign policy, given on March 8 this year by Dr. Dina Moulioukova from the University of Miami. Dr. Skrzypczyńska met, among others, with leva Mainardi, an employee of the European Parliament staying at the Center, as an EU Fellow. She also used the resources of the Center's library (several books published by the Center were transferred to the library of the Faculty of Political Sciences and Journalism of Adam Mickiewicz University, Poznan, Poland). Moreover. Skrzypczyńska also gave a guest lecture at the Center of the European Union. The lecture was devoted to the current topic of EU sanctions in the context of the aggression of the Russian Federation against Ukraine.

Professor Paulina Pospieszna was invited to give a talk at the Centre for European Studies (CES) at the University of British Columbia, Canada. The talk was about the EU sanctions and aid in response to Russia's invasion of Ukraine. Prof. Pospieszna was invited by newly elected CES Director, Prof. Katherine Bowers, to give a speech and share her research resulting from the grant on the EU sanctions. Prof. Pospieszna has published five articles in high impact factor peer-reviewed journals that contribute to the understanding of European politics. societies, and external affairs. The findings were of the interest to the Center's faculty members. postdoctoral fellows and graduate students across the Social Sciences and Humanities who could listen to her talk in person or online.



Centre for European Studies (CES) at the University of British Columbia, Canada is currently undergoing a transition from the established in 1998 the Institute for European Studies. As the result of these changes the Center was searching to expand cooperation with the scholars from Europe who are conducting research on the European Union extensively.

The speech and presence at the Center created an opportunity to create a stimulating space for discussing European scholarship and current internal and external affairs of the EU. It was also a great chance to promote the Jean Monnet Center of Excellence at AMU at the UBC Center for European Studies and to establish cooperation that might provide the opportunity for faculty members and students in both institutions.

The conference was organized by the Center for European Studies Alexandru Ioan Cuza. Her presentation's title was the following: evolving concept multilateralism in EU foreign policy. Impact of the pandemic COVID-19 and the war in Ukraine.

Since 2013 the EURINT conference has established itself as one of the most visible academic events in field of European Studies from Central and Eastern Europe. EURINT Conference series usually comprise keynote lectures and panel debates involving international academic experts, followed by intensive Q&A sessions. The academic programme also includes parallel academic sessions during which the conference participants (researchers, students, young professionals, etc.) are expected to deliver presentations of their most recent research.
